## **Membership Information**

-The Nevada Country Club Month runs from the 26<sup>th</sup>-25<sup>th</sup>. Payment for your bill from the prior month is due upon receipt. Any payments made after the 15<sup>th</sup> are charged a 2% late fee.

-All Resident Membership levels have a \$40 monthly food & beverage spending minimum. This can be used on food and liquor upstairs and down. There is no charge if you use at least \$40. If for example you use \$25 in a billing cycle there will be a \$15 F&B Charge on your bill.

-All Golfing Memberships pay a trail fee of \$60 paid in 2-\$30 installments (April and October).

### **Full Membership:**

A person age 21 or over.

Entitles the member and member's family (except family members over the age of 25 years old or those that reside outside of the home) full use of the Club.

Member must pay Stock Fee of \$300. Monthly Dues of \$145.00 and a monthly spending minimum of \$40.00.

### **Non-Resident Membership:**

A person residing outside the county.

Entitles the member and member's family (except family members over the age of 25 years old) full use of the Club.

Monthly Dues of \$80.00

### **Social Membership: (Non-Golfing)**

Entitles the member and member's family (except family members over the age of 25 years old) use of the tennis courts, swimming pool and Clubhouse functions.

Member must pay monthly dues of \$70.00 with a monthly spending minimum of \$40.00 to be used in the dining room or snack bar for food and drink. There will be no stock or voting rights for Social Members.

**\*NEW MEMBERS:** Must prepay first 6 months dues.

### **Youth Limited Single Golf Membership:**

A youth under 21, access to golf course, pool access charged at guest rates. No food and beverage minimum. \$60 monthly, limited number- board approval. Trial fees and cart shed additional if cart is utilized.
